

AGREEMENT

about carrying out students practice  
V. I. Vernadsky Taurida National University

We, the undersigned, V. I. Vernadsky Taurida National University, (hereinafter - the "University"), represented by Acting rector V. P. Kazarin, acting on the basis of the Statute, on the one hand, and University college ALDAR (hereinafter - the "Practice Base"), represented by Prof. Dr. Ezz Hattab, acting on the basis of the Statute on the other hand, entered into an agreement for the students practice:

**1. The practice base undertakes:**

- 1.1. To accept on a free basis students for practice in accordance with the educational process schedule.
- 1.2. To appoint qualified specialists for direct student practice management.
- 1.3. To create appropriate conditions for students to complete the internship program, prevent the occupation positions that do not correspond to the internship program and future profession.
- 1.4. Provide students with safe working conditions at each workplace. To conduct mandatory briefings on labor protection: the introductory and one in the workplace. If necessary, to train students-interns safe work methods.
- 1.5. To provide students-interns with the opportunity to use technical and information resources necessary for the implementation of internship programs.
- 1.6. To ensure work accounting for student internships. All violations of labor discipline, internal regulations and other violations shall be reported to the University.
- 1.7. At the end of the internship, to give a description of each student-intern, in which to reflect the quality of the report prepared by him, and so on.
- 1.8. To provide students with the opportunity to collect information for term papers and dissertations on the results of the enterprise activity, which is not a trade secret.

**2. The University undertakes:**

- 2.1. To provide the internship base with the internship program for approval two months before the start of the internship, and not later than a week to provide a list of students who are sent for internship.
- 2.2. To appoint qualified teachers as practice leaders.
- 2.3. To ensure that students comply with labor discipline and internal regulations. To participate in the commission's practice base investigation of the accidents if they occurred to students during the internship.

**3. Responsibility of the Parties:**



3.1. The parties are responsible for non-fulfillment of their obligations to organize and conduct practice in accordance with labor legislation in Ukraine.

3.2. All disputes arising between the parties to the contract shall be resolved through negotiations between the Parties, and in case of impossibility - in the prescribed manner.

3.3. The Agreement shall enter into force upon signature by the Parties and shall be valid for five years.

3.4. The Agreement may be terminated only by agreement of the Parties.

3.5. The Agreement is concluded in two copies: one for each Party. Copies are identical and have the same legal force.

3.6. By signing this Agreement, each of the Parties in accordance with the Law of Ukraine "On Personal Data Protection" provides the other Party with an unambiguous unconditional agreement (permission) to process, use, store, transfer to third parties and destroy their personal data in written and/or electronic form in the amount contained in this Agreement, invoices, acts and other documents relating to this Agreement, in order to ensure the implementation of civil, commercial, administrative, tax and tax relations, and also each Party confirms that it has received notification of:

- entering personal data into the personal data base of the other Party;
- the rights, as a subject of personal data, the purpose of collecting this data and the persons to whom this data is transferred.

The Parties shall ensure that the personal data of individuals contained in this Agreement and the documents related to its conclusion, execution, termination are lawfully obtained.
